प्रदेश में ग्रिड कनेक्टेड सोलर रूफटाप कार्यक्रम फेज-2 हेतु निर्गत कार्यालय-ज्ञाप सं 4809/नेडा-एसई-रूफटाप-फेज-2/2019 दिनांक 20.12.2019 के बिन्दु-04 के अनुसार लाभार्थी एवं इम्पैनेल्ड फर्म के मध्य होने वाले अनुबन्ध के संबंध में निम्नवत उल्लिखित है:-

THIS AGREEMENT made the _____ day of _____, _____ between Mr/Ms. _____ (Name), Aged _____ S/o / D/o _____ of _____ (Address) (hereinafter "Beneficiary"), of the one part, and _____ (name & address) of _____ (name of agency) (hereinafter "the Firm"), of the other part :

WHEREAS _____ is a registered beneficiary having application ID/ registration no. _____ for the installation of Grid connected Solar Rooftop power plant under the Grid Interactive Rooftop Solar Power Plants of MNRE Phase-II and the Solar Power Policy 2017 of Uttar Pradesh.

WHEREAS M/S. _____ is an empanelled Firm for the implementation of the programme with empanelment no. _____ of UPNEDA. Whereas the Agency has accepted the work order from the beneficiary for the installation of solar power plant for the sum of Rs. _____ /-. Hereinafter "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

The Firm shall install solar power plant at the site of beneficiary as per the details in the Feasibility Report prepared after site visit and the terms contained in the work order issued by the beneficiary. The system installed should comply with technical requirements

1. UPERC RSPV Regulation 2019
2. The system of the components should comply the technical compliance required by Ministry of New and Renewable Energy, Govt. of India (MNRE) and as per tender of UPNEDA, tender no. 01/UPNEDA/SPV/GCRT/2019-20
3. The installation and commissioning of the system will be done in compliance with installation practices and guidelines. The finalization of work order is done on mutual consultation.
4. All disputes with respect to payment of beneficiary share, supply and installation, post installation service and maintenance (if any) will be sorted out between us. Government or any other Firm providing subsidy or co-ordinating programme implementation will not be having any role in legal disputes arising out of this.

The installation should be completed while inspection representative of Firm will fill up the entries and the commissioning report by the Firm / Beneficiary to be uploaded in concern Discom office / UPNEDA portal within the stipulated timeline.

The whole system should be warranted for 5 years and the Solar module provided should have a performance warranty of 90% of the rated output at the end of 10 years and 80% at the end of 25 years.

The installation work will be done according to the MNRE/Tender technical specification, only domestic manufactured modules and solar cells to be used. If there is any deviation, no subsidy shall be permissible. Further third party inspection can also be carried out by UPNEDA/Discom, if any deviation from the technical specification is found, action will taken to Blacklist the concerned agency.

Agencies shall conduct periodic service visits at least once in six months during the warranty period of 5 years, Inspection report to be entered in O&M book for repair or replacement of any parts/ material.

Any complaint or service call from the beneficiary shall be attended by the agency within 72 hours and problem has to be rectified within 7 days. The agency will provide his mobile no and local service center address to the beneficiary. In case performance of Firm is un-satisfactory then Discom/UPNEDA will take necessary action against the Firm. For any complaint beneficiary can send e-mail to

In case any difference or dispute arises in connection with the contractor, all legal proceedings relating to the matter shall be instituted in the Court within whose jurisdiction the power plant is (presently/ proposed to be) located.
